Vale of White Horse District Council welcomes the progress of the Minerals and Waste Core Strategy and recognise its importance as part of the overall Development Plan for the district and the county of Oxfordshire. The Council particularly supports the clause in Policy M8 that recognises the need to take into account sites allocated for development in an adopted local plan or neighbourhood plan and to clarify the relationship between the Mineral and Waste Local Plan and other parts of the 'development plan'.

Policy M3: Principal locations for working aggregate minerals (**MM20**), states that the principal locations for aggregate minerals extraction will be within "strategic resource areas" as shown on the Policies Map, and that specific sites will be allocated in the Part 2 plan. The council continues to have concerns over the north/south split and the evidence behind this split.

The Vale of White Horse District Council would like to highlight the delivery of a new strategic road connection between the A415 east of Abingdon-on-Thames and the A4130 north of Didcot, including a new crossing over the River Thames which continues to be a priority for Vale of White Horse and South Oxfordshire District Councils in their respective Local Plans. This need for a new river crossing has been established through the adopted Vale of White Horse Local Plan 2031 Part 1 (Core Policy 17), as land is safeguarded to enable the future delivery of this piece of infrastructure, which is located within this Mineral Strategic Resource Area 5. The Council would not wish proposals located within the Mineral Strategic Resource Area 5 to prejudice or jeopardise the future delivery of this scheme.

The Water Resources Management Plan (WRMP) 2014 published by Thames Water identifies three potential options to address its long term water resource management in the south east. Working positively and constructively with Thames Water, the Council has safeguarded an option for a smaller reservoir solution at Longworth in the adopted Local Plan 2031 Part 1 (Core Policy 14). This is located partly in the Mineral Strategic Resource Area 7. Again, the Council would not wish proposals located within the Mineral Strategic Resource Area 7 to prejudice or jeopardise the future need and delivery of the reservoir.

The emerging Vale of White Horse Local Plan 2031 Part 2, although at a relatively early stage, proposes to safeguard land for the possible future provision of a South Marcham Bypass linking the A415 to the west of
