The City of London Corporation supports policy W6 *Landfill* and in particular its intention that “*Provision for disposal of Oxfordshire’s non-hazardous waste will be made at existing non-hazardous landfill facilities which will also provide for the disposal of waste from other areas (including London and Berkshire) as necessary....*”

The City of London Corporation is the Waste Planning Authority (WPA) for the business and financial district which covers one “Square Mile” of central London. Provision of waste sites within the Square Mile is problematic due to the high density of development. The City therefore relies on WPAs elsewhere in London and beyond to co-operate in the provision of waste facilities to accept waste originating in the City. We welcome the confirmation in the Oxfordshire Minerals and Waste Local Plan Core Strategy that provision will continue to be made for London’s waste as necessary.
