OXFORDSHIRE COUNTY COUNCIL (COWLEY ROAD CARNIVAL) (SPECIAL EVENT) ORDER 2024

WHEREAS the Oxfordshire County Council ("the Council") is satisfied that vehicular traffic should be temporarily prohibited from or restricted in various roads in Oxford to facilitate the holding of the Cowley Road Carnival on 1 September 2024 ("The Event").

NOW THEREFORE the Council, in exercise of its powers under Section 16A of the Road Traffic Regulation Act 1984, and all other enabling powers, make the following Order:

- Save as provided by Article 2 of this Order, no person shall when appropriate signage is in place, except under direction or with the permission of a police constable in uniform or the Council, cause a vehicle to proceed or wait, or wait for the purposes of loading and unloading in the Sections of Road specified in the Schedule to this order on Sunday 1 September 2024.
- 2. Nothing in Article 1 of this order shall render it unlawful for a person to cause or permit a vehicle to proceed or wait, subject to the progress and safety of the Event, in the sections of road specified in the Schedule to this Order:
 - a) if being used for police fire or ambulance service purposes;
 - b) if being used in connection with emergency works to any sewer or to any main pipe or apparatus for the supply of gas, water, electricity, or telecommunications in, or on any land adjacent to the sections of road;
 - c) if being used in The Event, or is being used by an authorised official in support of or for safety reasons of the event;
 - d) for access to premises in or adjacent to the road, providing that such cannot be undertaken other than by using the closed Sections of Road,
 - e) for access to side roads, or premises in such roads between The Plain and Jeune Street inclusive.
- 3. The prohibitions imposed by Article 1 shall apply in relation to any part of the Sections of Roads to such extent and at such times as there are in place traffic signs within the meaning of section 64 of the Road Traffic Regulation Act 1984 indicating that such prohibition is in operation at that part.
- 4. The relevant provisions of the following orders) shall be suspended for the duration of the Event:
 - (1) The City of Oxford (East Oxford) (Controlled Parking Zone) Order 2000 (as amended) to suspend the use of permit parking for residents and businesses, and to remove the one-way traffic restrictions in Bullingdon Road and Rectory Road;
 - (2) The Oxfordshire County Council (Oxford Area Various Streets) (Traffic Management) Order 2022 (as amended);
 - (3) The Oxfordshire County Council (Disabled Persons Parking Places Oxford) Order 2010 (as amended) to suspend the use of parking places.

Note: Permanent restrictions created in support `Low Traffic Neighbourhoods` that prohibit vehicle access in certain roads may be suspended as required to assist traffic flow and enable diversionary routes.

5. This Order may be cited as the Oxfordshire County Council (Cowley Road Carnival) (Special Event) Order 2024 shall have effect only on the 1 September 2024. The Council is satisfied that it is not appropriate for the event to take place other than on the highway
