OXFORDSHIRE COUNTY COUNCIL (MOTIV SPORTS UK LIMITED OXFORD HALF MARATHON) (SPECIAL EVENT) ORDER 2024

WHEREAS the Oxfordshire County Council ("the Council") is satisfied that vehicular traffic in various roads in the Oxford area should be temporarily prohibited and/or restricted from 12 October 2024 to facilitate the holding of the Motiv Sports UK Limited, Oxford Half Marathon ("the Event") on Sunday 13 October, and it is satisfied that it is appropriate for the event to be held mainly on public roads.

NOW THEREFORE the Council, in exercise of its powers under Section 16A of the Road Traffic Regulation Act 1984 and all other enabling powers make the following Order.

Definitions

1. "The Sections of Road" in this order means those roads or lengths of road specified in the Schedules to this Order.

Prohibition of Vehicles

2. Save as provided by Article 5 of this Order no person shall, when appropriate signs are in place, except under the direction of, or with the permission of a police constable in uniform, cause or permit a vehicle to proceed in the Sections of Road specified in Schedule 1 to this Order, except Jackson Road.

Prohibition of Waiting and Loading

3. Save as provided by Article 5 of this Order, no person shall when appropriate signs are in place, except under the direction of, or with the permission of a police constable in uniform, cause or permit a vehicle to wait, or to wait for the purposes of loading or unloading in the Sections of Road specified in Schedule 1 to this Order.

Prohibition of Waiting and Loading

- 4. Save as provided by Article 5 of this Order, no person shall when appropriate signs are in place, except under the direction of, or with the permission of a police constable in uniform, cause or permit a vehicle to wait, or to wait for the purposes of loading or unloading in the Sections of Road specified in Schedule 2 to this Order.
- 5. Nothing in Article 2, 3 or 4 of this Order shall render it unlawful for a person to cause a vehicle to proceed or wait in the specified Sections of Road if it is being used:
 - (a) for the purposes of police, fire or ambulance services;
 - (b) in connection with the organisation, conduct or safety of the Event;
 - (c) under controlled access to property;
 - (d) for emergency works to the highway and utility services in or adjoining the Sections of Road.
- 6. The prohibitions imposed by Articles 2, 3 & 4 of this order shall apply in relation to any parts of the Sections of Roads to such extent and at such times as there are in place traffic signs (within the meaning of section 64 of the Road Traffic Regulation Act 1984) indicating that such prohibition is in operation at those parts.

Suspension of Traffic Orders

- 7. The relevant provisions of the following orders shall be temporarily suspended insofar only as they are affected by the measures required for this Event:
 - (1) in respect of roads specified in Schedule 1
 - a) The Oxfordshire County Council (Disabled Persons Parking Places Oxford) Order 2010 (as amended),
 - b) The Oxfordshire County Council (Central Area Oxford) (Controlled Parking Zone and Waiting Restrictions) Order 2011) (as amended)

- c) The Oxfordshire County Council (Oxford Central Area) (Designation and Regulation of Street Parking Places) Order 2002 (as amended).
- (2) in respect of roads specified in Schedules 2 and 3 The Oxfordshire County Council (Summertown) (Controlled Parking Zone and Various Restrictions) Order 2004 (as amended),
- (3) In respect of the road in Schedule 4 The Oxfordshire County Council (City of Oxford) (Central Area) (Traffic Management) (Consolidation) (Order) 2003 (as amended) in respect of the Suspension of Prohibitions of Access in Keble Road and Turl Street.
- 8. This Order may be cited as the Oxfordshire County Council (Motiv Sports UK Limited Oxford Half Marathon) (Special Event) Order 2024 and shall have effect from 12 October 2024 for the duration of the measures associated with the Event.
