

**OXFORDSHIRE COUNTY COUNCIL  
(ABINGDON MARATHON)  
(SPECIAL EVENT) ORDER 2024**

**WHEREAS** the Oxfordshire County Council (“the Council”) is satisfied that traffic in various lengths of road in and around Abingdon should be temporarily prohibited or restricted to facilitate the holding of the Abingdon Marathon on Sunday 20 October. The Council is satisfied that the event cannot be held wholly off road and that it in the interest of road safety that vehicular traffic should be temporarily restricted.

**NOW THEREFORE** the Council, in exercise of its powers under Section 16A of the Road Traffic Regulation Act 1984, and all other enabling powers make the following Order.

6. Save as provided by Article 4 of this order no person shall, when appropriate signage is displayed, except under the direction of or with the permission of a police constable in uniform or enforcement officer, cause a vehicle to proceed in the lengths of road specified in Schedule 1 to this order, except for controlled access to premises only accessible from the lengths of roads.
2. Save as provided by article 4 of this order, no person using a vehicle in any of the roads specified in column 1 of Schedule 2 to this order, shall drive in a direction other than that specified in column 2 of the said Schedule.
3. Save as provided by Article 4 of this order every person driving a vehicle in any of the lengths of road specified in column 1 of Schedule 3 to this order shall, when appropriate signage is displayed, cause the vehicle to make the turn into the road and in the direction specified in columns 2 and 3 respectively of the said Schedule.
4. Nothing in Articles 1, 2, or 3 of this order shall render it unlawful for a person to cause a vehicle to proceed, or to proceed other than in the prescribed direction (as appropriate) in any of the lengths of road specified in the Schedules to this order if the vehicle is being used:
  - (1) for police, fire or ambulance services;
  - (2) in support of the event by authorised persons for safety purposes.
5. The prohibitions imposed by Articles 1, 2 & 3 of this order shall apply in relation to any part of / and any of the lengths of roads specified in the Schedules to this order to such extent and at such times as there are in place traffic signs (within the meaning of section 64 of the Road Traffic Regulation Act 1984) indicating that such prohibition is in operation at that part.
6. This order may be cited as the Oxfordshire County Council (Abingdon Marathon) (Special Event) Order 2024 and shall have effect on Sunday 20 October 2024.

Drayton Road to Milton Road, Sutton Courtenay, both directions	From its junction with Milton Road, eastwards through Brook Street	To its junction with Church Street/High Street
