

Bus Service Tender Results

Since deregulation of bus services in October 1986, the County Council has been required by law (the Transport Act 1985) to make available for public inspection the results of tenders received for supported local bus service contracts.

The Council is permitted to award certain low-cost ('de minimis') or short-term contracts without competitive tender and to award negotiated contracts if no acceptable tenders are received.

This publication contains details of tender awards made in the period January to December 2021. A separate list of 'de minimis' and funding agreements made at the same time are included in Parts 2 and 3.
