OXFORDSHIRE COUNTY COUNCIL (CHIPPING NORTON MOP FAIR) (SPECIAL EVENT) ORDER 2024

WHEREAS Oxfordshire County Council ("the Council") is satisfied on grounds of public safety that vehicular traffic in certain roads should be prohibited or restricted and alternative routes provided to enable the annual the Chipping Norton Mop Fair ("the Event") to take place on the highway, and the Council is satisfied that it is not practical to hold the event other than on the road.

NOW THEREFORE, the Council in exercise of its powers under Section 16A of the Road Traffic Regulation Act 1984 and of all other enabling powers hereby make the following Order:

- 1. The `Sections of Road` in this order are as specified in the Schedule to this order.
- Save as provided by article 4 of this Order, no person shall, when appropriate signage is in place, except under the direction of or with the permission of a Police Constable in uniform or the Council, cause or permit any vehicle to proceed in any of the Sections of Road specified in Part 1 of the Schedule to this Order.
- 3. Save as provided by Article 4 and except under the direction or with the permission of a Police Constable in uniform or the Council, no person shall, when appropriate signage is in place cause or permit any vehicle to wait at any time in the Sections of Road specified in Part 2 of the Schedule to this Order.
- 4. Nothing in Article 2 or 3 of this Order shall render it unlawful for a person to proceed or wait in any of the Sections of Road specified in Part 1 of the Schedule to this Order if the vehicle is being used:
 - (a) for the purposes of the Police, Fire and Ambulance services,
 - (b) in connection with the setting up or dismantling of the event,
 - (c) to enable access to premises in such lengths of road, and/ or enable a vehicle to be loaded or unloaded,
 - (d) in connection with emergency works to any sewer or to any main pipe or apparatus for the supply of gas, water, electricity, or telecommunications in, or in any land adjacent to, a length of road specified in the Schedule to this Order.
- 5. Save as provided by Article 6, when appropriate signage is in place and except under the direction or with the permission of a Police Constable in uniform, no person shall cause or permit any vehicle to proceed in the sections of road specified in column 1 of Part 3 of the Schedule to this Order in a direction other than that specified opposite to it in column 2.

- 6. Nothing in Article 5 of this Order shall render it unlawful for a person to proceed other than in the direction specified in any of the sections of road specified in Part 3 of the Schedule to this Order if the vehicle is being used for the purposes of the Police, Fire or Ambulance services in an emergency,
 - provided that it shall not be in contravention of this restriction for a person who wishes to use any parking place in those lengths of road, or to enter or exit premises or property adjacent to the road, to manoeuvre into or from such place by means of forward and reverse gears.
- 7. The prohibitions imposed by Articles 2, 3 and 5 shall apply in relation to any part of the Sections of Road to such extent and at such times as there are in place traffic signs (within the meaning of section 64 of the Road Traffic Regulation Act 1984) indicating that such prohibition is in operation at that part.
- 8. The relevant provisions of the following Orders shall be temporarily suspended insofar only as they relate to:
 - (1) permitted or limited waiting in the lengths of road specified in Part 1 and Part 3 of the Schedule to this Special Event Order as follows:
 - (a) The Oxfordshire County Council (Various Roads West Oxfordshire) (Prohibition and Restriction of Waiting and Permitted Parking) Order 2012 (as amended) Parts IV and VI of the Order and Schedules 22, 37 and 40.
 - (b) The Oxfordshire County Council (West Oxfordshire District) (Disabled Persons Parking Places) Order 2006 (as amended) article 4 and Schedule 1.

and:

- (2) The Oxfordshire County Council (Market Place, Chipping Norton) (Traffic Regulation) (Amendment) Order 1999 to suspend the one-way restriction in High Street.
- 9. This Order shall be cited as The Oxfordshire County Council (Chipping Norton Mop Fair) (Special Event) Order 2024 and will be in force from 19 September 2024 until the termination of the measures associated with the Event.
