



"BOU PRO" – excess capacity, health warning on front of box incorrectly worded and missing entirely from the rear, missing CLO warning markings, no UK responsible body specified, delivery per puff not provided and no raised tactile warning.





"ALADDIN PRO" – excess capacity, no size in ml given or delivery per puff, no UK responsible body specified, missing CLP warning markings and designed to resemble an item of food/drink as prohibited by Regulation 38(3)(d).





"BIFFBAR" and "BIFFBAR LUX" – excess capacity (13ml), incorrect health warnings on some products, no UK responsible body specified, delivery per puff not specified,

missing CLP warnings & no raised tactile warning.





"ETH CRYSTAL BLING" – excess capacity, no raised tactile warning, CLP warning labelling incomplete.





"PRIME BAR" – excess capacity (18ml), health warning on back of box too small, no raised tactile warning and no UK responsible body specified.





"OG SUPER SMASH" – excess capacity (20ml), no health warnings on front or back, missing raised tactile warning, no delivery per puff specified and resembles a soft drink as prohibited by Regulation 38(3)(d).





ELUX Legend 3500 and ELUX MAX 4000 – excess capacity, no UK responsible body specified, no raised warning for the visually impaired, statutory warning missing from rear of box.





Aroma King 7000 – excess capacity (10ml), no UK responsible body specified, no raised warning for the visually impaired, statutory health warning incorrectly worded.





RandM Tornado 7100 and RandM 10,000 - excess capacity (10ml), no UK responsible body specified, no raised warning for the visually impaired, statutory warning missing from rear of box and and missing CLP warning markings.






Reymont Meta 3788 - excess capacity, no UK responsible body specified, no raised warning for the visually impaired and missing CLP warning markings.





M-BAR Extra Puff - excess capacity (10ml), no UK responsible body specified, no raised warning for the visually impaired, statutory warning missing from rear of box.





Beco Bar – excess strength (5%), no UK responsible body specified, incorrectly worded statutory health warning.





Puff Plus – excess capacity (3.2ml), excess strength (5%), no UK responsible body specified, incorrectly worded statutory health warning.





Vape With a Bang XXL – excess capacity (6ml), no UK responsible body specified, incorrectly worded statutory health warning, missing CLP warning markings.





VU Lounge – excess capacity (4.8ml), statutory warning missing from front & rear of box, money-off promotion included with purchase of item.





Geek Bar Pro – excess capacity (4.5ml), no UK responsible body specified, missing CLP warning markings.





Hipster – excess capacity (8ml – 2x 4ml dual flavour device), no UK responsible body specified, missing CLP warning markings, statutory warning missing from rear of box and incorrectly worded in any event.





Vapeman Solo+ 800 (they also do a 1500 and 1000) – excess capacity (3.2ml), excess strength (5%), no UK importer/responsible body, incorrect statutory health warning, no CLP markings.





Nord Bar – excess capacity (8.5ml), no UK responsible body specified, no raised warning for the visually impaired.





Magic Bar 1500 – excess capacity (5ml) excess nicotine content (5%), no UK responsible body specified, lacks visual & tactile warnings and health warning incorrectly sized & worded.





VAPMOD Allspark 5K – excess capacity (15ml), no UK responsible body specified, no raised warning for the visually impaired or other pictorial toxicity warnings.





Ignite 1500 - excess capacity (5.1ml) excess nicotine content (5%), no UK responsible body specified, lacks visual & tactile warnings and health warning incorrectly worded.






Vabar "Captain" - excess capacity, no UK responsible body specified, no raised warning for the visually impaired, missing CLP warning markings and health warning incorrectly worded.



Vabar "Robust" - excess capacity, no UK responsible body specified, no raised warning for the visually impaired, missing CLP warning markings and health warning incorrectly worded.







ENE "LEGEND 3500" - excess capacity, no size in ml given or delivery per puff, no UK responsible body specified and no raised warning for the visually impaired.





"ENJOY ULTRA" – excess capacity, no size in ml given or delivery per puff, no UK responsible body specified, missing CLP warning markings and no raised warning for the visually impaired.





"SUPBLISS BINGO" – excess capacity (16ml), no UK responsible body specified, no raised warning for the visually impaired, health warning incorrectly worded and missing from rear of box entirely.





"FIREROSE" EX4500 - excess capacity (12ml), no UK responsible body specified and no raised warning for the visually impaired (essentially an ELUX 3500/4000 in a slightly different box).





"CRYSTAL" PRO MAX and BIG ONE – excess capacity (10ml), health warnings are too small, no UK responsible body specified and no raised warning for the visually impaired.
